OPS & Bank Street Ed Center: A Year in Review

PARTNERSHIP OVERVIEW

The OPS and Ed center teams have designed a multi-year partnership to focus on the coherence between Pre-K and K-3 as a critical lever to ensure equitable and high-quality teaching and learning.

This partnership is designed to build coherence throughout the early childhood years, beginning in the first year with Pre-K and K alignment, and continuing through grade 3 in subsequent years.

THE ESSENTIAL QUESTION

How do we design PreK and K developmentally meaningful learning experiences that are culturally responsive across early childhood classrooms and lead to success in first grade?

STRATEGIC PLANNING

OPS district leaders and the Bank Street Ed Center team conducted weekly meetings to build district strategy and to align the goals of the partnership and professional learning with the District's Strategic Plan.

EC COLLABORATIVE REVIEW

OPS and the Ed Center partnered to generate learnings to inform the district's early childhood strategy and approach. Grounding in the essential question, the Ed Center team facilitated a collaborative reflection of early childhood practices, resources, and supports within the district; and then generated a qualitative report to analyze and discuss key findings with district leadership.

LEARNINGS

- Early Childhood Vision/Mission
- Consistently provide equitable and developmentally meaningful learning and teaching environments
- Strengthen culturally responsive teaching practices
- More professional learning opportunities

- Purchased dramatic play centers, puppets, and a beginner block center for every K-classroom in the district
- Created a vision and mission statement for early learning
- Two in-person PD sessions:
- Two virtual meetings with Pre-K and K teachers and paraprofessionals

PD Session 1 – Provided an overview of the three practice areas but spent time in the first two.

- 1. Relationship-based interactions and intentional instruction (goal was to understand the importance of relationships in learning)
- 2. Responsive classroom environments (goal was to explore what dramatic play looks like in action and within the standards)

93% of participants agreed the session activities helped them better understand the features of responsive classroom environments.

Teacher Meeting 1 - Dramatic Centers & Strengthening our Practice Goals:

- 1. Reflect on "play" as the work of early childhood
- 2. Connect the work of centers to the cognitive development in young children
- 3. Focused on what works, trouble-shooting, and strategy sharing

94% of participants agreed they had time to reflect on their practice and think about ways to incorporate new learnings.

Teacher Session 2 - Play to Learn & Strengthening our Practice

Goals:

- 1. Reflect on the connection between dramatic play and social studies
- 2. Connect the work of centers to the cognitive development of young children
- 3. Develop strategies to deepen and extend social studies through centers and dramatic play

91% of participants agreed the session helped them to understand the connection between centers and cognitive development.

PD Session 2 - Block Building

Goals:

- 1. Notice and review block units
- 2. Engage in collaborative planning and building in a block center
- 3. Reflect upon new knowledge around block building in classroom environments 100% of participants agreed the session activities helped them to gain new insight and knowledge around block building in their classroom environments.

- After the block play PD session, we order an historic number of blocks/shelves for K and Prek
- Model block center and PD for the preschool instructional coaches (will be open for the K-2 coaches as well)
- Met with all the Elementary School Principals and Executive Directors
- New York School Visit S.T.E.A.M. Exhibition





NJDOE – Office of Grants Management

- This office aids Local Education Agencies (LEAs), through the establishment and maintenance of systems to plan for, acquire, award and manage grant funds in a fair and equitable manner to support initiatives that promote academic excellence, teacher and leader effectiveness, school innovation, and accountability.
- This office is responsible for three broad functions in support of an efficient, effective and accountable grants management system:
- (1) Planning: working collaboratively with program offices to design subgrant programs that are consistent with the Department's goals and priorities;
- (2) Subgrant implementation: supporting the implementation of individual grant projects to promote educational success; and
- (3) Oversight and compliance: ensuring that the Department's grants management system, including the management of subgrant programs, will withstand the tests of audit and public scrutiny.

Grant Opportunities

- Corporate, University, and Community Partner Grants
 - Independent research of grant opportunities as well as partners extending a grant opportunity for a specific initiative to include but not limited to: innovative programming, curriculum resources, staff recruitment and development
- Notice of Grant Opportunities (NGOs) are received from the NJDOE Office of Grants Management as they become available via federal and/or state resources
 - <u>Discretionary Grants</u>: These grants are awarded to selected agencies to address specific education initiatives. Clear eligibility requirements are identified, and grant applications/support are provided to eligible LEAs.
 - <u>Entitlement Grants</u>: These grants provide funds to specific grantees based on a formula, prescribed in legislation or regulation, rather than on the basis of an individual project review. The formula is usually based on such factors as population, enrollment, per capita income, or a specific need. Applicants do not compete for these funds.
 - <u>Competitive Grants</u>: These grants are limited in levels of funding and number of awards granted; all applicants are competing for funds and applications should be submitted fully attending to all application requirements.
