After School Programs & Student Supply Lists

- Families, all after school program offerings are within the Return to School Letters as sent out by each principal, the Week of August 16th.
- All tentative after school programs are posted on all websites as of this time and date.
- Student Supply Lists have been posted since June of 2021 on each school's website.
- You are encouraged to review the district as well as your child school's website. We want you to know everything possible for the return to schools. We have worked diligently to ensure the smooth transition back.

Considerations: Testing & Vaccinations

Keeping school buildings open depends upon awareness of and immediate action on any COVID-19 concerns in our buildings.

The District instituted voluntary weekly rapid-testing in all school buildings beginning on May 24, 2021. Our testing partners at JL Hudson Holdings, LLC come to district schools each week and test in-person staff and students from grades 1-12.

On **Tuesday, September 14, 2021**, the district is initiating a **Mobile Vaccine Clinic** running from **3:30pm-6:30pm** at Lincoln Avenue School using the Pfizer vaccine.

- Tuesday, September 14 for 1st dose and Tuesday & October 5 for 2nd dose.
- Everyone 12+ is eligible to receive the vaccine. The clinic is open to all – students, faculty, families, etc.
- **Preregistration:** A Google Form will be created and sent out to staff and families



Considerations: Instructional Time and Masks

On May 17, 2021, Governor Phil Murphy announced the requirement that schools must provide full-day, in-person instruction, as they were prior to the COVID-19 Public Health Emergency. In September 2021, our students educators, and parents can look forward to the full return to safe, in-person instruction.

- Instruction must occur 180 instructional days (as defined by the district calendar and can be in person or virtual).
- School day will be the length of the school day.

Note: Remote learning will be permitted under certain circumstances such as when there is a declared localized outbreak or other emergency.



Considerations: Social Distancing Protocols

The District will continue to implement physical distancing measures as an effective COVID-19 prevention strategy to the extent the schools are equipped to do so while still providing regular school operations to all students and staff in-person.

Space between students in classrooms:

- In Pre-k and elementary classrooms, students will be seated **at least 3 feet apart**.
- In middle schools and high classrooms, students will be seated **at least 3 feet apart**.



Classroom Configuration

- Social distancing to maximum extent practical
- Students will be socially distanced with a minimum of 3 ft apart
- Classrooms are already outfitted to maintain social distancing
- Limit sharing of items or clean between use



Standards for Health & Safety



Considerations: Masks and the Mandate

Masks will be required by all staff and students. We simulated this actionable during the summer of 2021 with much success.

Masks will be required in all classroom and non-classroom settings, including hallways, school offices, restrooms, gyms, auditoriums, etc. and for all students, teachers, staff, and visitors. Masks breaks will be provided as well.

All students, educators, staff, and visitors will be required to wear face masks indoors for the start of the 2021-2022 school year.

Mask use will be required on school buses and other public transportation. Visitors permitted in school will be required to wear masks at all times.

All face coverings (whether disposable or reusable) must:

- Be made with at least 2 layers of breathable materials
- Fully cover the nose and mouth and secure under the chin
- Fit snugly but comfortably against the side of the face
- Be secured with ties or ear loops and allow the user to remain hands-free
- Without exhalation valves or vents

Clear masks that cover the nose and wrap securely around the face may be considered in certain circumstances including for the teaching of students with disabilities, young students learning to read, or English language learners.

Considerations: Hand Hygiene & Respiratory Etiquette

We will continue to teach and reinforce hand washing with soap and water for at least 20 seconds. If soap and water are not readily available, hand sanitizer that contains at least 60% alcohol can be used (for staff and older children who can safely use hand sanitizer).

We will inform students and staff to cover coughs and sneezes.

Used tissues should be thrown in the trash and hand hygiene as outlined above should be performed immediately. }

We will maintain adequate supplies including soap, hand sanitizer with at least 60 percent alcohol (for staff and older children who can safely use hand sanitizer), paper towels, tissues, and no touch trash cans. }

Hand hygiene should take place: Upon arrival at school. Before and after meals and snacks. After going to the bathroom. Before leaving for the day. } After blowing nose, sneezing, or coughing into tissue. When hands are visibly soiled. Assist/observe young children to ensure proper hand washing.

Considerations: Cleaning & Ventilation

Cleaning and disinfecting are important defenses against the spread of the Coronavirus, but only if it is done properly. As part of our cleaning and disinfecting protocols, the District will:

- Continue the increased frequency of facility cleaning schedules that includes cleaning and sanitizing with a particular emphasis on commonly touched surfaces
- Ensure continuous disinfecting of classrooms and therapy rooms that service students with complex disabilities
- Continue to discourage sharing of common materials when possible.
- Clean all common areas between periods
- Properly clean and disinfect highly used surfaces between uses

The District has ensured proper **ventilation systems** inclusive of

- Repaired windows and are in the process of adding new screens
- Added AC Units
- Continuous changing of air filters

Meals at the School Site

- Maintaining physical distancing between students and staff
- Considering alternatives to use of group dining areas such as eating in classrooms or outdoors.
Staggering eating times to allow for greater physical distancing.
- Maintaining student cohorts and limiting mixing between groups.
- Avoiding offering self-serve food options.
- Discouraging students from sharing meals.
- We will continue routine cleaning between groups

Transportation from September 7th through the end of the Year

- School buses will follow the same procedures as our school buildings.
- Masks must be worn by all passengers on buses, regardless of vaccination status per CDC's Federal Order.
- If occupancy allows, maximize physical distance between students.
- Open windows to increase airflow in buses and other transportation.
- Regularly clean high touch surfaces on school buses at least daily.

Illness while on the School Site

Children and staff with COVID-19 symptoms should be separated away from others until they can be sent home. Students who are sick and not already wearing a mask should be provided one to wear unless the student has a contraindication to doing so. If a mask is not tolerated by the ill student or staff member, other staff should be masked and follow maximum physical distancing guidelines (at least 6 feet away).

Ask ill student (or parent/guardian) and staff whether they have had potential exposure to COVID-19 in the past 14 days meeting the definition of a close contact. Individuals should be sent home and referred to a healthcare provider. Persons with COVID-19-compatible symptoms should undergo COVID-19 testing.

Schools with testing capacity should test ill students and staff, consistent with any federal and state requirements, including requirements regarding parental consent. Ill individuals who test positive should be reported to the LHD and contact tracing should begin. Ill individuals that test negative should be referred to a healthcare provider, who may consider additional COVID-19 testing

Reporting Procedures if COVID-19 Positive Results are shared at the school/district level

The district will notify LHDs when students or staff are ill and have potential COVID-19 exposure; and when they see an increase in the number of persons with COVID-19 compatible symptoms.

In the event of a positive test, the district will be prepared to provide the following information when consulting with the LHD: Contact information for the ill persons; The date the ill person developed symptoms, test positive for COVID-19 (if available), and when was last in the building;

Types of interactions (close contacts, length of contact) the person may have had with other persons in the building or in other locations; Names, addresses, and telephone numbers for ill person's close contacts in the school; Vaccination status if known.

ASSESS RISK

Students and staff must be safely and respectfully isolated from others AND cannot return to campus until the school system's reentry criteria are met.

Institute a short building dismissal for cleaning, disinfecting, contact tracing in consultation with local health officials; Potential 2 – 5 days of closure.

Exclusion Criteria for those found to have tested Positive for COVID-19

Ill individuals with COVID-19 compatible symptoms who have not been tested or individuals who tested positive for COVID-19 should stay home until at least 10 days have passed since symptom onset and at least 24 hours have passed after resolution of fever without fever reducing medications and improvement in symptoms.

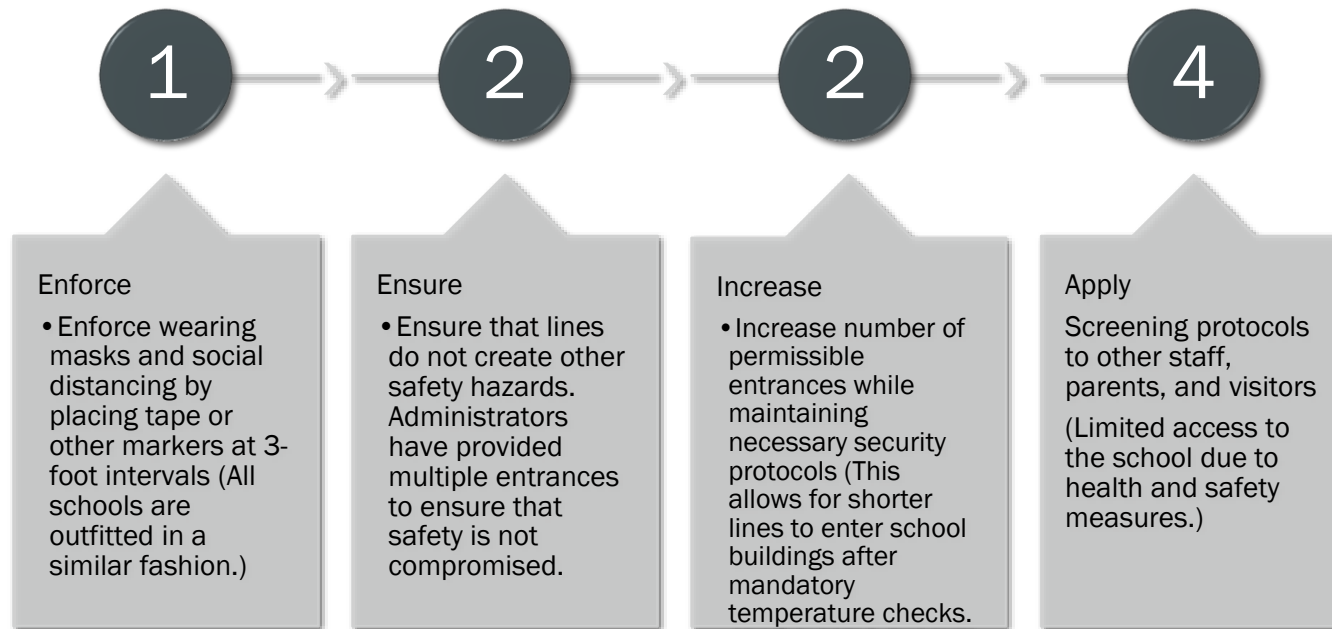
Persons who test positive for COVID-19 but who are asymptomatic should stay home for 10 days from the positive test result.

Remote Instruction & the 180 Requirement

Pursuant to N.J.S.A. 18A:7F-9, schools must be in session for 180 days to receive state aid. The statute requires that school facilities be provided for at least 180 days during the school year. Section (b) notes that where a district is required to close the schools of the district for more than three consecutive school days due to a declared state of emergency, declared public health emergency, or a directive and/or recommendation by the appropriate health agency or officer to institute a public health-related closure, days of virtual or remote instruction commensurate with in-person instruction will count towards the district's 180-day requirement.

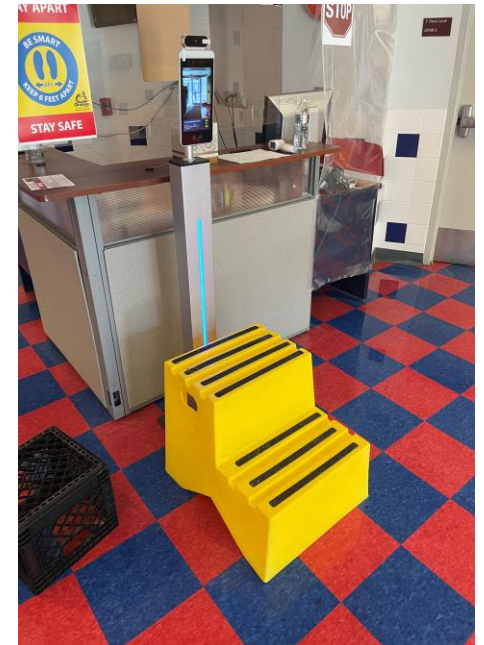
The district may be confronted with the incidence of COVID-19 positive cases amongst staff and/or students. [If an district is required to exclude a student, group of students, a class, or multiple classes as a result of the scenarios listed above, while the school itself remains open for in-person instruction, the district should be prepared to offer virtual or remote instruction to those students in a manner commensurate with in-person instruction to the extent possible.](#) In circumstances when the school facilities remain open and in-person instruction continues in those classrooms that are not required to quarantine, those days in session will also count towards the district's 180-day requirement in accordance with N.J.S.A. 18A:7F-9.

School Level Entry and Movement



Supports for All Stakeholders: Health and Safety

- Hygiene protocols – Handwashing / sanitizing throughout day (In all bathrooms as well as hallways, protocols are evident to remind staff and staff accordingly.)
- Cleaning and disinfecting protocols – Between classes, equipment touched in recess periods, after sharing of items within closed cohort, other commonly touched items
- Controlling flow of traffic in building (See the attached picture.)
- Not coming to school with any symptoms (mandatory daily COVID-19 questionnaire must be filled out by all staff and students when entering the district.)



Symptoms of COVID-19

Symptoms may appear 2 -14 days after exposure to the virus.
People with these symptoms may have COVID-19:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches

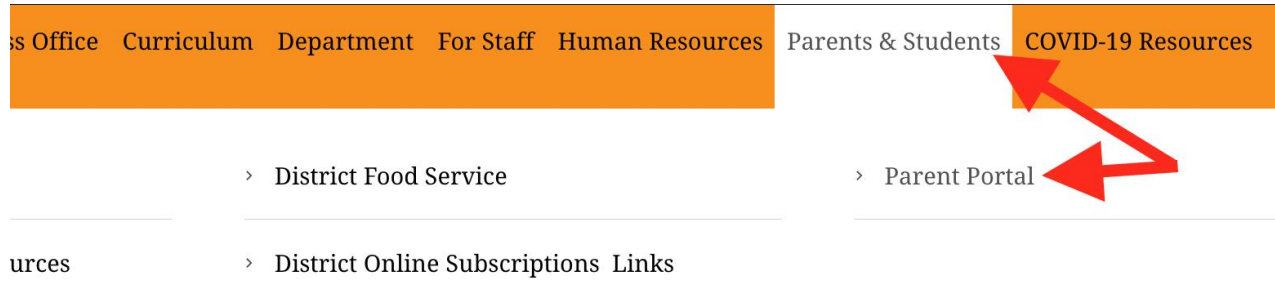


Additional Symptoms of COVID-19

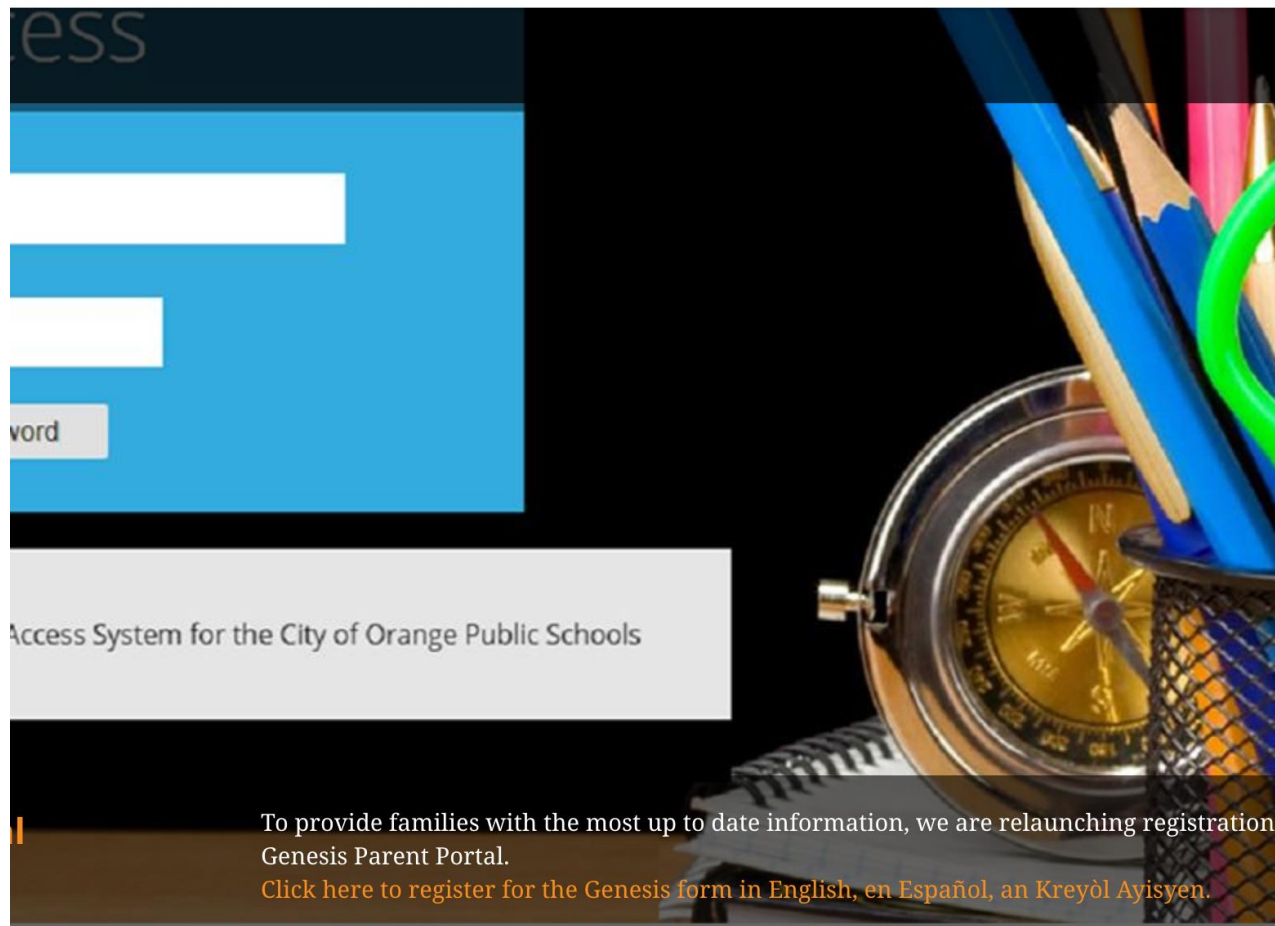
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

Special Note: All schools are outfitted with isolation rooms should students become sick during the day. The most important component is that when called, the parent/guardian must come immediately to pick up the sick child. This allows for lessening the spread of illness.

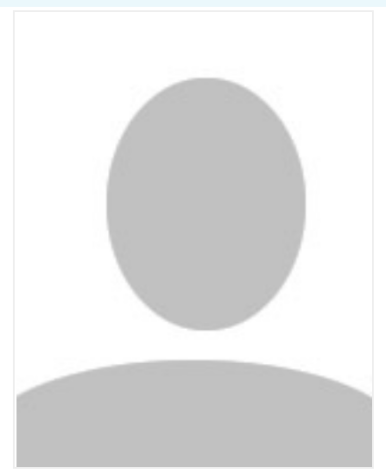

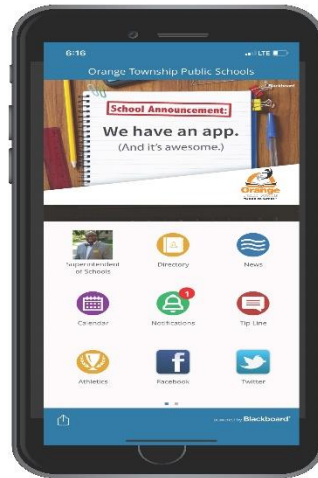
