


Superintendent's Report Graduation Rate 2011-2020 Orange Public Schools "Good to Great"

Portfolio Appeals Process Waived for 2019-2020 School Year

Executive Order 117, signed April 7, 2020 by Governor Phil Murphy, waives the graduation assessment requirement for any twelfth-grade student who is expected to graduate in the Class of 2020 but, as of March 18, 2020, had not yet met the graduation assessment requirement. Students in the Class of 2020 who have not yet met the assessment requirement must still meet all the other State and local graduation requirements, including but not limited to credit, curriculum, and attendance requirements.

The First Pathway as Part of the Assessment Graduation Requirements

• In the area of English Language Arts, students must obtain a score of 750 or higher (Level 4)-English 10

• In the area of Mathematics, students student must obtain a score of 750 or higher (Level 4)-Algebra I

- Throughout the Month of September, we held Back to School Nights at all 14 locations virtually. Special thank you to all administrators, staff, and families for making these nights so powerful. In addition, thank you Board of Education Members for taking part in each of the evenings. You are appreciated.
- As you know, we continue to provide breakfast and lunch to our school community. With that being said, we have distributed over 56,000 meals since March 17th. Continue to come out and grab a meal students.
- As you know, I like to share great news as it comes in. On Monday, September 21, 2020 at eleven in the morning, Principal Blanton of the Orange Early Childhood Center successfully defended her dissertation. Dr. Blanton's study was on Teachers' Perspectives on Reading Fadeout and Strategies to Prevent It in Low-Performing Schools. Dr. Blanton completed her doctoral studies at Walden University. Please join me in congratulating Dr. Blanton on her successful defense.

- We continue to provide top notch synchronous instruction daily to our students pre-kindergarten through twelve. When I tell you that popping into classrooms and seeing staff who have worked tirelessly to provide sound practices to our students would certainly be an understatement.
- We have continue to implement school spirit and pride days throughout Phase I that ended on October 2, 2020. What a great time this has been for our students and staff. This momentum has already taken form now that we are in Phase II of the Return to School Plan. Please continue to follow us on Facebook, Twitter, and Instagram accounts. We are posting multiple times per day. The district made a promise to consistently give updates and that we are certainly doing.

• The Grading, Retention, and Promotion Manual is undergoing some revisions. On Tuesday, September 22, 2020 and Monday, September 28, 2020 a committee to assist in the revision of the Grading Manual took place. Suggestions regarding kindergarten report cards to social emotional comments from kindergarten to Grade 12 were explored. I am confident that when the Curriculum committee sees the final product, you will certainly be impressed as well as the full Board of Education. The goal is to ensure that the manual is up to date and speaks to the current nuances in educational practice. Stakeholders from teachers to parents and community as well as administrators are on the committee. All voices are valued and appreciated.

- As you know, Phase I has now ended and we are going to move into Phase II. As a reminder to each of you: Orange High School as Mr. James reported out on at the last Executive Session (September 8, 2020), the SDA requested that they have access to OHS (Beginning October 5th through October 23rd) in the effort of updating some areas of the school building. Staff will begin Phase II very soon.
- On another note, the construction at 123 Cleveland Street (the New Early Childhood Center) continues to move in a positive direction. The teachers in that building will also continue in Phase I until the Week of October 26th where they will begin Phase II, Remote Synchronous.

- As Phase II began, Mr. James received communication that the Association of School Business Officials International presented the Orange Township Public School District with commendation regarding the Comprehensive Annual Financial Report for the Fiscal Year that ended on June 30, 2019. As indicated our school district was awarded due to our outstanding financial reporting. Thank you to Mr. James for leading this effort as the School Business Administrator.
- Monday, October 5th was World Teachers' Day. An announcement was sent out to All Users from me celebrating our teachers. For your edification, the following denotes World Teachers' Day: World Teachers' Day, also known as International Teachers Day, is an international day held annually on the 5th of October. World Teachers' Day aims to focus on "appreciating, assessing and improving the educators of the world" and to provide an opportunity to consider issues related to teachers and teaching. Special thank you to our teachers (and this title encompasses our support staff, paraprofessionals, security, food service, and our parents who are taking on a partner role during this pandemic phase.

- Last school year, our seniors garnered over 18 million dollars in academic schools. This announcement was ongoing throughout the course of the school year, but we are committed to even more this school year. We have held Naviance training courses for our students as well as FASFA Family Nights. We are committed to supporting students on their path of choice.
- The Computer Science Donation we received from Apple Electronics in partnership with Rutgers University-Newark continues is something that we must be reminded of. For the CS track at Orange Preparatory Academy, Orange High School, and STEM Innovation Academy of the Oranges Apple Laptops and Tablets are being disseminated to strengthen the CS trajectory. Please be reminded that we garnered \$219,000.00. I shared this great news at the second June Board Meeting.

- Plan B was recommended to the Board of Education on August 11, 2020.
- Remote Synchronous commenced on October 5, 2020 and conclude on November 25, 2020 (7 Weeks)-At this time we are in Phase II. Special Thank You to all Staff for their triumphant return to Brick and Mortar. As a reminder to each of you: Orange High School as Mr. James reported out on at the last Executive Session (September 8, 2020), the SDA requested that they have access to OHS (Beginning October 5th through October 23rd) in the effort of working on some electrical items. Remember, if we did not use this time to do as such, the completion date of OHS would certainly be pushed back. We did not want to explore that option so the teachers at Orange High School will be able to return to brick and mortar in September 2020. On another note, the construction at 123 Cleveland Street continues to move in a positive direction. The teachers in that building will also continue in Phase I until the Week of October 26th where they will begin Phase II, Remote Synchronous.
- Soft Launch will commence on November 29, 2020 and conclude on December 23, 2020 (3.5 Weeks)
- Full Re-Entry will commence on January 4, 2021 through the end of the year.
- It is important to note: Based on recommendations from the Governor's Office, the NJDOE as well as our Director of Health in Orange Township, shifts in the plan can potentially take place.
