BOARD MINUTES

November 14, 2017 - Closed Meeting November 14, 2017 - Public Meeting

BOARD COMMENTS

- Mr. Adekunle James, (Board Secretary) performed the roll call to start the public session at about 7:10 PM followed by the Flag Salute. Mr. Lee called for all in attendance to keep standing for a moment of silence in honor of (Ms. Charmaine Fraser) a staff of the district who passed recently. Then a performance was rendered by students and teachers from Cleveland Street elementary school.
- Mr. Lee, then read and presented Resolution G17-051 in memory of Ms.
 Charmaine Fraser, the board approved the resolution. Mr. Lee introduced Mr.
 Walter Riglicki from the Audit Firm of Samuel Klein, who presented the report on the district's audit, Comprehensive Annual Financial Report (CAFR) for the fiscal year ended June 30, 2017. He reported that the district performed very well in its financial operation as of June 30, 2017 with no audit findings.
- Mr. Lee notified the public and provided an update on the ongoing district school plays and he encourage parents and community members to come out and attend the schools performances. He informed that Orange High School (OHS) was recognized (the Second time) by the College Board for Advance AP Courses. He commended the staff and students of OHS.
- Mr. Lee recognized Ms. Yancisca Cooke, Forest Street School Principal, for achieving her doctorate degree. Mr. Lee also recognized Ms. Belinda Smiley, who will be retiring at the end of December 2017, and that this meeting is her last official Orange Public Board meeting.
- Mr. Lee then gave a brief but detailed presentation on the School Board Election process and the election timeline. On the point of caution, he notified the public that this is the first time the district is going through this process, which we are still learning as we go and more information will be obtained and shared with the community as we proceed.
- Mr. Lee then conducted the Student of the month award presentation followed by the Cleveland Elementary School Parent of the month recognition.

PUBLIC COMMENTS

- Terra Shield, parent at Rosa Parks Community School, informed the public that her child is in Ms. Catenzerites's class, was doing very great, but now that her child has a Substitute teacher in the class, her child has not been doing well. She requested for a solution from the district and encourages the district to try and use less Sub-Teachers who might not have a good qualification to teach.
- Mr. Lee responded that the district has a problem with filling our classes with subs when teachers are absent, our salary is low, we are going to Montclair State University (MSU) to recruit teachers. The district has been underfunded by up to \$13 Million. The incoming Governor has promised to fund the School Aid Formula according to the statute. If that is done we plane to first improve our teacher's salary guide. Teachers leave the district for more money elsewhere. We will try to do the best we can to keep teachers.
- Charles Gamboa, parent at Forest Street School, presented his letter of concern to the board and spoke about his understanding of the lack of adequate security staff at Forest Street School. He indicated that there use to be two security officers but now there is only one officer.
- Mr. Lee responded that he will look into his matter with the BA and our supervisor of security services.
- Rev, Anthony Johnson, presented that he voted in November to support the change of the district board from Type I to Type II and he is not in support to have the school board election in November. He wants to encourage the board not to vote on the resolution G17-048 which will approve that school board elections be held in November, but the board should consider having the school board election in April.
- Tyrone Tarver, 258 Ogden Street, wanted to correct the things that the school board has said, he claimed that the deadline for January election was not November 14, according NJ statute the January election is deadline is January 23 and the deadline to notify the County Clerk is November 24 ten days after November 14. He indicated that the City BA and County Clerk reached out to the district BA and the Superintendent for two weeks but calls were not returned. He claimed that he was in process with others of writing petition to have the school board election to happen and was in constant contact with the City BA's and County Clerk's office. The City Clerk, in 2016 placed a referendum which he personally help to draft to be placed on the ballot to have the school board voted to move from Type 1 to Type II, from January to November the district was in touch with the County Clerk, so this is not the first time the district is going through this process. 86% of voters wanted the election in January, they also wanted the school board election in April so that they can vote on the school budget &Tax Levy. If the board chooses the November election, the citizens don't have to vote on those two items. He claimed that the cost of the March election was not up to \$45,000 but he obtained information from the County Clerk that it cost only \$20,800. The board has spent more money in legal expense to challenge the citizens & voters. From the audit report today, the district has about \$6 million in fund balance.

- Mr. Lee responded that Mr. Tarver's claim that the City BA and the County Clerk calls to his office is not true. Mr. Lee informed he was not around in January 2017 and in November/December 2016 he was leaving the district and was not personally involved in the process. Mr. Lee further stated that he and the board president met with the County Clerk and the information he presented earlier about the election was the information he obtained at that meeting with the county Clerk. Since we are new in this process, we are in the process of reaching out to other districts, County Offices and School Boards for information. Mr. Lee recommends that going forward we can't be dwelling on the past, there may have been some miscalculations or errors, we all should consider leaving the past, and collaboratively move on. The board will consider looking further into the issue and opportunities of either the March or November election. We are looking at information on all the schools in NJ with November or March elections. He believes there are still other school boards who votes on their budget and they have March or April, we see in the papers who had their budgets approved or turned down. Because they can't go into the following year after June 30 without an approved budget, they must be doing it before November. The county clerk informed us at the meeting that majority of the districts in New Jersey have November elections and in Essex County only two districts still have a April school election (Mr. Tarver interjects that only the excess of tax levy cap and bonds etc are voted on in November). Mr. Lee indicated that even South Orange has a November election and they voted on the budget question on the ballot. It should be on record that this administration is not doing anything to block the democratic process of the citizens of Orange. We are trying to help move the process forward. We had a two and a half hour meeting with the County Clerk. The approx. \$40,000 estimate cost of election came from county or city. As to the county or city officials calling my office, that did not happen.
- Derrick Henry 260 Ogden street, spoke in support of Mr. Tarver, he claimed that he doesn't understand what kind of encouragement and or example the district is board trying to set by moving the election to November and not Aprill.
- Mr. Carter said that his interest and he believed the reason of the entire board to move the election to November is to give more time and make it an open process, give ample opportunity and more time to prospective board candidates to identify themselves, and for these candidates to share with the community their ideas and what they plan to bring to the board, also to share with the community, what they need to do to help improve the district, what they intend to focus on in terms of teaching and learning, how do they plan to support and integrate the information that you hope that parents can take advantage of to support their children's learning. He will like to hear what the candidates will offer to be part of the solution to part of this process. His believe is that Orange is on the rise and we will continue to do so, and his expectation is that those who come to the board to identify themselves to be part of the board should be solution oriented and try to help us improve wherever we stand right now.
- Gloria Stewart, she commented that she support the change to an elected board. She feel like the board is dragging its feet in this process, she believe that the board should give the public the benefit and credit to go through the election process of their choice. She said that she understands Mr. Lee's feelings and trust his judgment. She believes that the board president and the

board is willfully holding back the election process. As to the budget and state aid that Mr. Lee mentioned, she hope that he and the board will keep the promise to improve the teacher's salary guide as compared to the neighboring districts so that we can be competitive and keep good teachers. As food for thought, she encourages Mr. Lee to coordinate and hold students of the month banquet ceremony.

- Mr. Lee informed the public that the district has and will continue to record and show many more of our students' instructional programs on channel 35.
 He informed that the goal of the district-wide page turners reading program for last year was one million but next goal will be one point two million.
- Jeffery Feld: Mr. James introduced and distributed a letter (public comment dated 12/11/2017) he received from Mr. Feld to all board members for the record. Mr. Ron Hunt Esq, also reaffirms to the board and public that Mr. Feld's comments in the letter will be taken into consideration, (see attached public comment questions from Mr. Feld).

WHEREAS, the City Council of the City (the "City Council") adopted Bond Ordinance Number 52-2017 on September 19, 2017 (the "Second Ordinance" and together with the First Ordinance, the "Ordinances"), which appropriated, and authorized the issuance of bonds or notes in the amount of, \$1,194,000 to finance the costs of the capital improvements authorized by the Second Board of School Estimate Resolution; and

WHEREAS, the Board of Education desires to acknowledge that it will assume and pay the principal of and interest on the School Promissory Notes maturing on December 7, 2018 and will be responsible for the issuance any permanent bonds or notes under the Ordinances.

Because I may not be able to attend Tuesday's BOE Regular Meeting due to a conflicting special City Council Meeting regarding the City's CY 2016 Corrective Action Plan, I respectfully request that this letter be distributed to all BOE members and that the following comments and questions be inserted into the official BOE public record.

I do not believe in coincidences. Tuesday night is the first night of Chanukah-a Jewish festival celebrating liberty and a rebellion against tyranny. Today, an interesting article by Marisa lati entitled: "Roselle: Judge to rule on community center disputc-Lawsuit aims to thwart project" appeared in the Star Ledger. This article raises many of the legal issues raised in my Feld related litigation.

Moreover, I was struck by the following paragraph in an article entitled: "Annals of Education: Two Schools of Thought-Success Academy's quest to combine rigid discipline with a progressive curriculum" by Rebecca Mead that appeared in this week's The New Yorker (Dec. 11, 2017):

"A school should be a model of what democratic adult culture is about," Deborah Meir, a veteran progressive educator, and a theorist in the tradition of Dewey, told me: Most of what we learn in life we learn from the company we keep. What is taught didactically is often forgotten." A corollary of Dewey's belief is that, if children are exposed in school to an authoritarian model of society, that is the kind of society in which they prefer to live."

Accordingly, I respectfully request real time responses to the following pertinent questions.

1. When will the BOE begin to post its meetings agendas 48 hours prior to its meetings?

2. On what date did the BOE adopt a resolution amending its By Laws and restricting

the amount of public comments to three minutes?

What is the status of the BOE's July 1, 2016 – June 30, 2017 Audit?

4. When is this Audit expected to be delivered to the Board and discussed at a public hearing?

5. Why the 90 day delay in producing the Park Avenue Lease to me pursuant to

OPRA?

6. Under what authority did the former BOE attorney execute and bind the BOE on this Park Avenue lease?

7. What is the updated status of the STEM Academy located in South Orange?

- 8. Who dropped the ball and delayed the special BOE election from January to March?
- 9. Does an appointed BOE have the statutory and moral authority to shift all BOE elections from April to November without providing reasonable notice and an opportunity to be heard to all stakeholders on this possible election date shift?

10. Should this election related issue be determined by the elected local governing body via two public hearings and adoption of an appropriate ordinance?

11. Has a BOE II monetary sanctions motion been filed against the local appointed BOE and its special outside litigation counsel?
