# **BOARD COMMENTS**

- Mr. Adekunle James, (Board Secretary) performed the roll call to start the public session at about 7:10 PM. Students of OPA rendered the Pledge of Allegiance and sang the Anthem. Mr. Dana Gaines, OPA Principal, rendered a brief presentation.
- Mr. James rendered a presentation on the November Election, going from a Type
  I district to a Type II, explaining the implications and gave lots of materials to the
  public on the subject.

# **ELECTION PRESENTATION QUESTIONS**

- Mr. Tyrone Tarver asked why the members of the public cannot vote on the budget. Mr. James explained in his presentation that statutes allow the public to vote when the budgeted tax levy increased by over the 2% allowed by state regulations.
- Ms. Gloria Stewart asked for reasons why the citizens cannot vote on a budget and the reasons why the election cannot be held in April instead of November.
   She said the board should not undermine the will of the Citizens of Orange. Mr. Carter explained that the election will still occur on March 13, 2018.
- Awards and recognition were bestowed on the Students and Parents of the Month.

## PUBLIC COMMENTS

- Rev. Johnson said he agreed with Mr. Tarver in not changing the election from April to November. He also said he did not agree with not voting on budgets. He said many people were enthused for the change to Type II. He said if the Type II option is approved, there are certain changes that will follow.
- Mary (parent) said she has come because of her daughter, stating that her daughter was kicked out of Orange because of a residency problem. She claimed that her 15 yr. old kid was also assaulted and nothing was done by the administration. She said they should allow her daughter to finish her schooling. She said another kid living in East Orange was left without being kicked out, claiming nobody reached out to her after the assault incident happened. Mr. Lee responded that he met with her regarding the residency matter, stating that she was given a letter prior to the meeting. She was given the opportunity to appeal and she did nothing. Mr. Carter asked her to meet him after the meeting to resolve the matter.

- Gloria Stewart acknowledged the award given to the parents of the month. She said the voting resolution was tabled during the December meeting. She asked for updates about the STEM building. She wants to know the progress of the playground. She also needed clarification on resolution D18-001. Mr. Lee responded to the questions on progress on the Stem Academy. He also responded to the playground renovation. Dr. Russo explained the resolution D18-001 explaining about the grant.
- Mr. Tyrone Tarver expressed concerns about the election dates moving from April to November. He also wanted to know what is being done about the \$2.55m bond. He wanted to know what the District did about the sexual harassment/assault allegation, how the District has handled it. He stressed that transparency is needed. Mr. Lee asked Ms. Alcantara to shed some light on the incident and steps taken. Ms. Alcantara said that the substitute teacher was removed from the building and the case reported to DYFS.
- Mr. James reported that he received a letter from Mr. Jeffery Feld, as his public comments, concerning certain questions pertaining to the BOE (see attached).

Dear Mr. James:

Because of the conflicting city council meeting, I am unable to attend Tuesday's BOE Regular Meeting. Consequently, I respectfully request that this letter be distributed to all BOE members and that the following comments and questions be inserted into the official January 9, 2018 BOE public record.

Civics matter. I do not believe in coincidences. One year ago, President Barack Obama delivered his Farewell Address to the Nation. In hindsight, this Farewell Address was historic and prophetic. It ranks with President George Washington's farewell warning to steer clear of permanent foreign alliances. It ranks with President Dwight Eisenhower's farewell warning of the industrial military complex. Indeed, President Obama delivered his remarks before the phrase "alternative facts" entered our lexicon.

On January 10, 2017, President Obama set forth his belief and commitment to our constitutional form of democratic participatory government. President Obama reminded us:

[D]emocracy does not require uniformity. Our founders quarreled and compromised, and expected us to do the same. But they knew that democracy does require a basic sense of solidarity-the idea that for all our outward differences, we are all in this together, that we rise or fall as one.

Politics is a battle of ideas; in the course of a healthy debate, we'll prioritize different goals, and the different means of reaching them. But without some common baseline of facts; without a willingness to admit new information, and concede that your opponent is making a fair point,

and that science and reason matter, we'll keep talking past each other, making common ground and compromise impossible. . . .

It falls to each of us to be those anxious, jealous guardians of our democracy; to embrace the joyous task we've been given to continually try to improve this great nation of ours. Because for all our outward differences, we all share the same proud title: Citizen.
