- The Board President welcomed everyone and requested that Dr. Fitzhugh render his report.
- Dr. Fitzhugh II reported on the Meet and Greet with new board members on December 17, 2019, where District goals were discussed. The Early Childhood registration is on the District's website along with all the information needed.
- He also reported on the 2nd Students recognition Program. He said on January 21, , schools will be honored. He showed the OPA video message, featuring Mr. Gaines, Principal at OPA. He reported on Forest Elementary School and what is being done outside of academics. Dr. Fitzhugh announced the next Students; recognition event will be on January 21, 2020. He also highlighted January's Instructional focus, comprising of writing and reading K-12. He also shared with the public the attendance report for December 2019.
- Mr. James rendered a presentation on our facilities being renovated by the SDA, Cleveland and OHS. He explained details of the facilities improvement to be done at Cleveland.
- Mr. Tarver, Board President, reported on the status of Development projects in the City of Orange and the likely impact on the District.
- Mr. Sherif reported on the Finances of the District, reporting on the Audit Submission to the State of NJ on November 23, 2019.
- Mr. Henry commended the efforts of the board in livestreaming the board meeting to make it available to all community members. He also extended his condolences to a crossing quard.

PUBLIC COMMENTS

• Ms. Singleton has concerns about breakfast being served cold and would like breakfast to be served warm. She also complained that some school conditions are dirty and would like something done. She also asked about transportation of students from Cleveland to PLV. Curriculum and LGBT issues were raised and need clarification. Dr. Fitzhugh addressed the curriculum issues and said our educators are well trained and that there is information on our website regarding financial literacy. He said the breakfast issue will be addressed with Mr. Tyrone Dorsey. He deferred to Mr. James regarding germs in the school. Mr. James reported that our custodial personnel use specialized chemicals to clean and prevent the flu.

- Ms. Rhonda Singleton spoke about good to great, referring to grades and would like to see improvement. She also mentioned the student recognition stating that the little kids in lower grades should also be included. She also referred to social and emotional learning, how it is being addressed and that she would like to see more work in this area. She advocated collaboration among all stakeholders. The Supt. addressed some of her concerns, stating that the teachers are on the forefront of improving the schools. He invited Ms. Singleton to meet with him to further discuss how improvements can be made in the District. Regarding social and emotional learning, he referred to a resolution to be voted on relating to this area.
- Ms. Patricia Arthur congratulated the new board members and those assuming different positions.
- Ms. Gloria Stewart said that consideration should be given to meetings scheduled. (board meetings and student recognition) She commended Mr. James with regards to the Finance presentation and Audit Submission. She also commended him for the facilities presentation.
