BOARD COMMENTS

- Roll Call was performed by Mr. James at 8:15 followed by the Flag Salute.
- The Board President welcomed everyone and asked for 10 seconds of silence for all who have passed due to Covid-19.
- The Board President requested Dr. Fitzhugh to render the Superintendent's Report for the month.
- Dr. Fitzhugh rendered his report, stating that the 2020 Senior Class has received \$15,448,774, in scholarships, \$1,401,082 more than SY 18-19. He added that scholarships continue to come in and he will give further updates when they do. He also reported that 4 students have received full scholarships to Vassar College, New Jersey City University, Hardwick College and Alabama St. University. Students have been accepted to Coppin St., Rutgers New Brunswick, Delaware State, St. Johns, etc., and will be featured on the website.
- Dr. Fitzhugh reported that the Plan for Instruction will be relaunched on April 20.
 There will also be a letter sent out regarding school closures. He also reported
 that self-care is being done with staff and students as well as virtual Spirit Days
 and performances by Visual Arts Students. He thanked staff and students for
 being engaged during this distance learning time.
- Dr. Powell and Ms. Harris rendered a presentation on Science and ESSA results from the 18-19 SY.
- Resolutions E20-006 to E20-008 were removed from the agenda.
- Mr. Sherif asked what was the overall improvement in the 2018-2019 ESSA results shown in resolution B20-010. Mr. Tarver and Dr. Fitzhugh addressed his concerns.
- The board discussed resolution G20-016. Mr. Tarver explained that the State Assembly passed a bill A-3901 for municipalities to seek permission from the State to defer tax levy payments to school districts.
- Ms. Kleen confirmed that it has not been voted into law yet.
- Mr. Sherif asked the reason for the bill. Ms. Kleen said it would be for tax relief for citizens. Mr. Sherif said it must be looked at closer because everyone is suffering financially. Mr. James said that we still must be able to pay the bills and staff.
- Mr. Tarver commented on resolution G20-015 stating Mr. Rodney West and Mr. Jason Cordes from the district IT Department will be improving the District's network capabilities and that he liked what he saw from the Technology Plan.
- Mr. Tarver asked Dr. Fitzhugh to report on the Grab and Go Breakfast and Lunch Program.

- Dr. Fitzhugh said the program began on March 17, 2020. We have condensed the amount of locations from 11 to 8 as of March 30, 2020. 8,655 students picked up breakfast and lunch as of April 3rd, 9,847 students as of today and we expect to reach 10,000 tomorrow. Information on the sites is available on the District website under the Covid-19 Resources page.
- Mr. Henry asked if there have been any leftovers issues with the Grab and Go program. Dr. Fitzhugh said there have been no issues.
- Mr. Sherif asked about the procedures for picking up lunches, stating that some parents have reported overcrowding. Dr. Fitzhugh said security has been enforcing the observation of social distancing and that there are no overcrowding issues. Mr. Tarver agreed with Dr. Fitzhugh's assessment.
- Mr. Tarver said that the city has stopped the use of crossing guards and asked that families take appropriate measures to escort smaller children to pick up meals.
- Dr. Fitzhugh added that students should go to the site closest to where they live and not to their home schools to pick up breakfast and lunch from the Grab and Go program.
- Mr. Sherif thanked the district staff, the board, and parents for working together during this time and hopes that we continue to do so till we see better days ahead.

PUBLIC COMMENTS

- Ms. Singleton asked, with the Governor closing schools indefinitely, will the senior prom and graduation be postponed until a later date? Will there be an Extended School Day program when this is over? Dr. Fitzhugh said we have not received a plan from the State as of yet so those events are not cancelled as of yet. We will listen for guidance from the Governor and Commissioner of Education and give updates when we receive information. He added that students will receive diplomas, Special Needs is planning virtual learning and the Extended School Day program will continue as planned.
- Ms. Kleen said the Extended School Day Program will continue to the extent possible. Ms. Daughtry said she saw a report mentioning Zoom graduations as an option. Mr. Sherif revisited Ms. Singleton's concerns and Dr. Fitzhugh addressed them.

RESOLUTION TO APPROVE BOARD OPPOSITION TO NJ ASSEMBLY BILL A-3902, WHICH ALLOWS THE DELAY IN TRANSMISSION OF QUARTERLY PROPERTY TAX REVENUE TO SCHOOL DISTRICTS

WHEREAS, The New Jersey School Boards Association opposes A-3902, which would authorize the Department of Community Affairs to permit municipalities to delay the transmission of property tax revenues to school districts during gubernatorial-declared emergencies; and,

WHEREAS, public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction. Continued timely transmission of school property taxes is critical for the education process to continue without interruption; and,

WHEREAS, A-3902, which is designed to ease a financial burden on municipalities, would place a

severe strain on school districts and the students and families that they serve; and,

WHEREAS, New Jersey's public schools are highly dependent on property tax revenue to support education programs. On average, local property taxes constitute 60% of public school revenue, with the percentage even greater in a significant number of districts. A delay in payments from municipalities will result in a financial crisis for school districts, seriously disrupting the educational process—and bringing it to a halt; and,

WHEREAS, although public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction. Continued timely transmission of school property taxes is critical for the education process to continue without interruption; and,

WHEREAS, under our state's current structure, municipalities are designated as the authorities to collect property taxes. But those taxes are levied for specific purposes—e.g., municipal, school, county, fire district—and these obligations must continue to be met; and,

WHEREAS, as currently written, A-3902, which is designed to ease a financial burden on municipalities, would place a severe strain on school districts and the students and families that they serve; and,

WHEREAS, NJSBA is committed to working with our state's lawmakers during this unprecedented crisis. However, we urge the Senate not to consider this legislation.

NOW, THEREFORE BE IT RESOLVED, that the Orange Board of Education approves the opposition to NJ Assembly Bill A-3902, which allows the delay in transmission of quarterly property tax revenue to school districts.
