- Roll Call was performed by Mr. Ayodele at 7:05pm followed by the Flag Salute
- Mr. Lee rendered the Superintendent's Report stating that school opening preparations are in progress. He specifically reported on the move of Cleveland Street to Our Lady of the Valley. He said that school opens on September 10, 2018 and that the STEM Phase II renovation is in progress. Demolition has started. He also said he attended the planning board meeting and updates on redevelopment were obtained. He also mentioned that one of the buildings

categorized as historical will not be demolished. He spoke of the possibility of obtaining another bond. He said on tonight's agenda is a presentation relating to goals for 2018-2019.

• Mr. Lee rendered a presentation of the 2018-2019 District Goals for student achievement and growth.

PUBLIC COMMENTS

- Derrick Henry expressed satisfaction that several board members encourage parental involvement. He said not discussing goals with parents runs the risk of losing the parent. He suggests a parents meeting.
- Gloria Stewart said she has been monitoring the progress at Heywood and is satisfied. She also asked if the student's recess was in compliance with the State's regulation. She spoke about the parent component, stating that there may be a problem if parents do not understand the program or curriculum. Also she stated that each family situation should be taken into consideration. She requested to see the relevant board policy. Mr. Lee addressed her concerns. He stressed the need for space in Orange and that he passed that along in the planning committee meeting in lieu of the growing population. Mr. Lee said there was no guidance from the DOE regarding recess.
