- Ms. Johnson notes that the previous committees will remain the same.
- Mr. Sherif emphasizes the board's role in making decisions based on students, parents, and the
 district, not personal interests. He acknowledges complexities and emphasizes the importance of
 avoiding political influence and supporting the administration's work to improve the educational
 district, not hindering progress.
- Dr. Turner, a board member, is committed to advocating for the district and collaborating with organizations to provide educational and support programs. She has contributed to the community by promoting literacy, offering student incentives, organizing charity events, and assisting families in need. She chairs the scholarship committee and supports students in affordable housing. Dr. Turner emphasizes the importance of voting in driving change and encourages Ms. Williams to engage fully and build relationships with board members. She welcomes Ms. Williams and reaffirms the board's shared commitment to student success.
- Mr. Ballard indicates that Ms. Johnson will send the committee assignments to the members of the Board of Education via email.
- Ms. Gravesande is inquiring whether a board member's refusal to participate in a committee would result in an unoccupied position or if they have the option to decline their responsibilities.
- Mr. Ballard indicates that the president of the board is responsible for appointing members to various committees. Should a member choose to decline their assignment, it is necessary for them to engage in a discussion with the president regarding a potential reassignment. Each committee is composed of three members, with the president typically serving on all committees. By restricting the size of each committee to four members, a quorum is avoided, thereby necessitating public meetings.
- Mr. Sherif inquires whether members are permitted to deliberate on the option of declining a committee assignment prior to the closed session and to notify the board president during that session before a conclusive decision is reached.
- Mr. Ballard indicates that board members have the option to notify the president promptly if they choose to refuse a committee assignment. It is unnecessary to wait for a meeting, as the allocation of committee assignments is determined at the discretion of the board president.
- Mr. Ballard indicates that the board will conduct a roll call vote to approve the committees, clarifying that this does not pertain to the composition of each individual committee.
