PUBLIC COMMENTS

- Ms. Arthur reported on resolution F16-025 & F16-026 stating that the resolutions were tabled during the last meeting. She said she is concerned that Board Members are in violation and that it is illegal. She also stated that resolution F16-033 not to renew the contract of the Superintendent after June 30, 2017 that she is appalled. She said none of the Board Members know about the progress the School District has made over the years. She added that the Public will fight on this matter.
- Ms. Gloria Stewart said she is disappointed about the behavior of the Board Members; that the Superintendent has been very effective in handling the affairs of the District. She said that there is need for continuity and the idea of taking out people is not good. She asked whether Mr. Lee would want to be in the District after 2017. She also said the Superintendent should be aware of those hired to supervise.
- Mr. Lee asked the Board reasons for the resolution F16-033. Ms. Mateo gave Mr. Lee
 a copy of a letter and stated that the Board would meet with the Superintendent at a
 later date to discuss the matter.
- Mr. James reported a letter received from Seventh Day Adventist to use the District's facility. He said there is need to find out whether the facility will be available.
- He also reported on letter received from Mr. Lee to retire on December 2016. He reported that at inception he worked diligently to avert the State's take over. Increased students achievements, increased students attending colleges, introduced a lot of programs and foster partnerships with industries and colleges. His work led to the District receiving over \$21 million dollars and that the District has improved significantly from when he met it. He thanked the Board for the opportunity to serve.
