- Ms. Arthur (Board President) welcomed members of the Public stating the purpose of the meeting and requested Mr. Lee to start his section of the presentation.
- Mr. Lee explained the objectives of the strategic planning meeting to members of the public, going through the mission and vision statements of the District, informing them about the current status of where the District is (present situation District-Wide) also
