COMMITTEE REPORTS

BOARD COMMENTS

- Roll Call was performed by Mr. James at 8:15 followed by the Flag Salute.
- The Board President welcomed everyone and requested Dr. Fitzhugh to render the Superintendent's Report for the month.
- Dr. Fitzhugh rendered his report, stating that the District has 3 winners from the New Jersey State Health Occupations Students Association (HOSA). HE also informed members that two staff members earned their educational leadership doctorates, Dr. Lottie Whitaker-Thornton on April 14, 2020 from the College of St. Elizabeth and Dr. Donna Sinisgalli from Kean University on April 26, 2020. Also, Ms. Whitley has been asked to film a lesson for NJTV Learning Live. Her lesson was submitted on May 11, 2020.
- Dr. Fitzhugh also reported on scholarships received by students in the district. As of this week we are at \$18 million in scholarships. He congratulated Heywood Avenue School for being recognized as a distinguished project Lead the Way school for the 3rd year. He recognized art teacher Ms. Vargle whose art is on display virtually at SOPAC as well as Nate Brown and Shana Falda from OHS. Teachers from Park Ave completed their Artificial Intelligence course through the International Society for Technology in Education and the General Motors Artificial Intelligence Program as well as Ms. Barrio, Ms. Martinelli and Dr. Harlem.
- Dr. Fitzhugh reminded the public about the Pre-K registration, stating that it began on May 11 and will continue through May 15 online on the District website. He also directed the public to send emails to prekindergartenregistration@orange.k12.nj.us if they have any questions.
- Dr. Fitzhugh informed members that we are working on virtual graduations and other activities for elementary and high school levels and that when plans are in order he will notify the public. He asked that the community visit our Covid-19 Resource pages and thanked Principals Innanucci and Alcantara, Dr. Russo, Ms. Epps and the tech team for heading the Chromebook kiosks. The next Kiosk will be on May 13, 2020 at Lincoln from 10am to 4pm. He also mentioned the self-care information for staff, students, and the community on the Covid-19 resource page, stating that there is a new update. He thanked social workers Ms. Jones and Ms. Laguna of OHS and all of our social workers for their work during this time.
- Dr. Fitzhugh also mentioned the Governor's decision to close schools as of May 4th and that he has shared it via letters and on the District website. He thanked the visual arts staff for the work they have been doing. Dr. Fitzhugh also reported that the District has been offering parent informationals in several languages. He thanked staff for helping families with online initiatives. He also thanked our food service workers and security staff for our Breakfast and Lunch to go programs, available at all schools, except OPA, OHS, Newcomers, and STEM from 7:30am to 9am. Up to today we have had 22,926 meals picked up. Lastly, he thanked all the families for emailing questions regarding distanced learning.

- Ms. Cabido read a comment she prepared regarding the Finance Committee meeting, stating that we understand these are trying times and that we hear the concerns of the community regarding the tax levy. We are asking the community to remain faithful to the vision we have for our schools and our children. We don't underestimate the strain but we have seen progress in important areas this year; that we can't continue to improve without the community's support.
- Ms. Johnson thanked Ms. Cabido for her comments.
- Mr. Tarver said that the tax levy had to move forward due to the situation the school district is in; that Dr. Fitzhugh and Mr. James structured the tax levy to make the impact on households the least painful as possible. He stated he was not in favor of it but he supports it moving forward and the community can also reach out to him to speak about it.
