BOARD COMMENTS

- Mr. James performed roll call at 6:12 pm followed by the Flag Salute.
- Dr. Fitzhugh presented on the district goals. The goals are available on the website.
 - Dr. Fitzhugh introduced the new Orange Public School App that allows all users to have real-time information on the happenings of the district. "All announcements are at your fingertips."
 - With the efforts of Dr. Russo and her team, the district was able to secure additional Chromebooks, which is expected to arrive soon.
 - We have received the COVID-19 Grant. Mr. James was able to purchase more Personal Protective Equipment (PPE).
 - The Department of Education has donated 9,496 youth size mask and 8,120 adult size face coverings to the district.
 - As it pertains to the return back to school, the soft launch has been postponed to January 19th. Full Re-Entry will start February 1st.
- Ms. Cabido commented on resolution C20-065. She commended the district on transferring funds from the field trip line to purchase more technology.
- Ms. Cabido inquired information on resolution D20-019. Mr. James informed the board that Sametric Research will provide a comprehensive evaluation of the progress of the district's 21st Century Program at Rosa Parks and Oakwood Avenue Community School. The areas include attendance, demographics, academic performance, and student relationships with the school, family, and community. Ms. Cabido inquired about the site visits. Mr. James replied that the contract does continues through 2021. When the students return in January or February, the vendor will conduct the site visits. If the district remains virtual, the vendor will evaluate the virtual programs.
- Ms. Cabido inquired about resolution D20-020. Mr. James noted that the agreement holds the vendor responsible for keeping all student data confidential. The data can only be shared with the Department of Education.
- Ms. Gravesande inquired about resolution E20-013. She asked if the donated items are pre-packaged or will community members pick out the items and touch multiple surfaces/materials. Mr. James replied that the items in fact would be pre-packaged according to the school administrator. Social distancing will be in place. It is similar to the kiosk we have when families pick up devices from the school. Ms. Daughtry asked if the children would receive little baggies. Mr. James replied that only the parents could pick up the items. It is for the family.
- Ms. Gravesande shared about a session she attended at the NJ School Boards Association Virtual Conference. The session was called "Healthy Staffroom, Healthy Classroom". She noted that the presenter was the superintendent of Point Pleasant School District. He shared that in 2014 a survey showed that 46% of teachers' stress level were extremely high. She wonders how much the percentage has increased since the pandemic. The presenter shared his district offers incentives to the staff for wellness participation like yoga and nightly walks. The incentives included raffling to win an IPhones and apple watches. Ms. Gravesande mentioned Dr. Fitzhugh's Wellness Wednesday, which is on every third Wednesday. She suggested partnering with yoga instructors in the community. The state's healthcare plan has a section called NJ Wells. If the staff meet the targets of the wellness check, the staff members get a rebate check of \$250. If the district can get 25% of

the staff to participate in the program, the district will receive a refund of 1% of the insurance premium. Ms. Gravesande noted that Pt. Pleasant took fifty percent of the refund and used it on incentives for the staff who participated in NJ Wells and used the other fifty percent to create new wellness initiatives.

- Ms. Daughtry stated that maybe the district could solicit recommendations from the community for wellness initiatives.
- Ms. Cabido spoke on a session she attended which was on The Importance of Reimagining the Gifted and Talented Identification Process to increase equity and access. She noted that legislation is suggesting using a more holistic approach instead of just grades. Students are able to demonstrate their abilities through various avenues. For example, a child can be gifted in math but not writing. Therefore, a student is not required to be "gifted" in all areas to qualify for the gifted and talented program.
- Ms. Cabido noted she attended another session on the board policies pertaining to equity of ESL students. The session discussed how the district could move from compliance to excellence. Ms. Cabido stated the district could explore ways in which the district can further support the ELL population. The district can explore ways to get other cultures more involved and engaged. She noted that there is a cultural barrier that prevents some families from advocating for their children. Some cultures perceive the administrators and teachers as the experts and therefore do not question their directives.
- Mr. Sherif shared that in one of the sessions he attended he learned the importance of the board partnering with the superintendent and periodically visiting the schools. It is important for the staff and students to see the presence of the board members. School visits allow the board members to obtain further insight on the operations and academic programs of the district. He noted that board members can engage in light friendly conversation during the visit but cannot discuss district business or make any commitments.
 - Ms. Kleen emphasized that all board members are required to coordinate visits with Dr. Fitzhugh.
- Mr. Henry commended the district on the progress made as it pertains to public relations. The district has revamped the district website, the district now has an app, and the district will now have its own broadcasting channel separate from the town's channel.
- Ms. Johnson added to Ms. Cabido comments. She stated that a large number of the
 Hispanic population do not participate because they are illegal. Ms. Johnson stated
 the district has to support this population and make them feel safe to participate.
 This group usually participates in the events that are free because they do not have
 to speak. They are able to come, pick up, then leave. The district should have more
 translators available at different events.
 - Ms. Daughtry added that this specific dilemma affects all nationality. She hopes the board can collaborate with Dr. Fitzhugh and his staff to implement a plan that will assist with the challenge of lacking participation from families who are from other cultures.
 - Mr. Sherif suggested having a translator available to translate the board meetings in multiple languages.
- Ms. Daughtry stated she cannot wait until Orange Public Schools is a blue ribbon school district. She can see it in the near future. She also thanked the district staff and administrators, parents, students, and the community for all their efforts during this pandemic. She also extended well wishes for those in Jamaica who were impacted by the terrible weather events.

COMMITTEE REPORTS

Finance Committee

- Ms. Gravesande reported that the deadline for the audit is extended to February 2021. It may extend until March. This extension allows the district to account for grants and the payment for the Sussex Transportation Co-op.
- The district is awaiting the arrival of Chromebooks that were previously purchased. The shipment was supposed to arrive on November 1, 2020. The district has taken liberty to order more Chromebook in addition to the ones that will arrive soon.

Curriculum Committee

- Ms. Cabido reported that the board is voting today on a resolution for a pilot program called the Rosie's Theatre Kids that provides 30-minute sessions for the fourth & fifth grade students at Cleveland Street School over a 10-week period. These students are already scheduled to take drama class.
- Ms. Cabido informed the board of a study being conducted with the Prekindergarten and Kindergarten teachers studying their literacy effectiveness and alignment to the learning standards.
- The district will continue their partnership with Montclair State and its Eco Explorers program. This program is offered to the district's sixth, seventh, and eight grade students. It introduces our students to environmental infrastructure and climates changes, as well as possible ecology career opportunities.
- The district received a donation of \$13,000 from the Youth Enrichments Service Prep School for Babies and Children and the AT&T Pioneers for VR and AR Initiatives. This will support the computer science program. This will expose them to coding, gaming, and gaming design.
- The board will be voting on the adoption of the AVID program at Lincoln Avenue School. It is a training program for new teachers that will enhance and reinforce academic behavior and higher-level thinking for fifth grade students in the first year. The hope is that that program will expand in the second year.
- Ms. Cabido also reported on the professional development that took place on October 12, 2020. She mentioned the opportunity that the teachers had to plan with teachers from other schools.
- She also mentioned the healthcare days that the district has on every third Wednesday for staff.

Facilities Committee

- Mr. Henry reported that the district is in the second phase of three required for establishing the district's broadcast channel. The district will purchase the equipment from Teleview.
- Construction at the high school was slightly delayed due to poor weather.
- Construction at Cleveland Street is delayed due to asbestos removal.
- A temporary sign will be erected at the John Robert Lewis Early Childhood center until the permanent sign is developed. The board will have to opportunity to review the design.
- The trees at the John Robert Lewis Early Childhood Center will be removed to create a safe environment.
- The district has ordered additional PPE equipment.

PUBLIC COMMENTS

- Ms. Brookins wrote to ask if the district applies for the P-EBT cards for the students for the month of October and November.
 - o Dr. Fitzhugh replied that he will forward this question to the reopening of school email. Ms. Brookins will receive a response from our Community Engagement Officer Mr. Barry Devone. Mr. Devone will address the PEBT cards and Ms. Brookins concern specifically.
- Gloria McElavine wrote to find out the status on Cleveland Street School. She stated it seems as if the construction is on the backburner. She added that she thinks the board should be more community friendly. It seems as if the board does not want any input from the community. She wrote, "We teach the students with your technology, and they are doing an awesome job. Why can't the board meetings be so presented?" She believes the board really does not want the community input. Ms. McElavine stated the district needs a universal device that reads an individual's temperature. She inquired if the district is doing all that they can do to keep everyone safe. She believes that the district makes all of its decision without the citizen's input.
 - Dr. Fitzhugh responded that the district held town hall meetings for the reopening of school planning. Surveys went out to obtain stakeholder's input. All of the schools held their own town hall meetings to gather feedback from the community. Dr. Fitzhugh specifically mentioned Cleveland's town hall meeting and noted the great attendance. He shared that if any family needs to update their information in Genesis, then the district can work on that tomorrow, so all families are receiving the phone blasts. The community is able to provide input by emailing the district at reopeningofschools@orange.k12.nj.us. The district sends out phone blast. Dr. Fitzhugh encourages the community to listen to all messages, so they do not miss-out on important information. Mr. James noted that the meetings are announced in newspaper outlets and on the district's webpage. Dr. Fitzhugh encouraged the community to visit the district's Twitter, Instagram, and Facebook page, as well as download the Orange Public School App to receive current information pertaining to the district. Dr. Fitzhugh works with Ms. Purkiss and Mr. Devone to ensure the outlets are updated daily with information.
 - o Dr. Fitzhugh shared that all visitors including himself receive a temperature check before allowed past security. Ms. Daughtry testified that temperatures are checked at district events within as well. Dr. Fitzhugh shared that in both previous board meetings and committee meetings Mr. James has reported on the PPE's that the district has purchased to ensure the health and safety of our staff and students. The district has gone above the requirements. Dr. Fitzhugh added that the conference rooms are disinfected after every meeting. Bathroom cleaning logs are maintained in every building. Door handles and other highly touched areas are disinfected around the clock.
 - o Ms. Gravesande added that the frequently asked questions section of the town hall meeting was used to draft the back to school plan. It was very inclusive of the community student, and teachers' voice. She noted that Dr. Fitzhugh always uses data to drive his decisions. He consulted with the local, county, and state health department to make decisions for the district. Ms. Gravesande encouraged all parents to get involved. Ms. Gravesande mentioned potentially making the meetings available on YouTube for community members who may not have a Facebook account. You can send

- Ms. Cabido informed the committee that comments and questions can be forwarded to <u>curriculummeeting@orange.k12.nj.us</u> Meetings are held every last Tuesday of every month at 3:30 pm. If you "like" the page, Facebook will send a notification about each meeting.
- Mr. Henry noted that the district is very transparent. The district has received state recognition for the level of interaction the district has with the community. Mr. Henry invited the community to visit the revised website and district calendar for dates of events and meetings, as well as to join on Facebook any virtual meeting.
- Mr. Wingfield chairs the human resource committee, which is confidential.
 However, the committee can share with the public the positions that are vacant at every board meeting. Currently the district has 13 vacant positions.
- Gloria McElavine added "If I am not able to exchange ideas with you, then you can assume. Everyone has to learn. Thank you Mrs. Gravesande."
