BOARD MINUTES

August 29, 2016 - Special Closed Meeting
August 29, 2016 – Special Public Meeting

BOARD COMMENTS

- Roll call was performed by Mr. James at 7:35pm. The Flag Salute was performed by students of Park Avenue School followed by a short rendition by members of the Park Avenue School Choir.
- Mr. Lee welcomed members of the public to the 2016-2017 School Year. He reported on his meeting with the Board on Saturday September 10, 2016 to establish goals for the District and on efforts made at improving the relationship with the police department. He also reported about the meeting held with the Mayor where Senator Sweeney was invited to speak on School Funding. Gov. Christie's plan to reduce funding was discussed at the meeting. He pointed out that the coordinator reportedly informed the legislature about his intention to start the \$6.900/child formula in the 2017-2018 School Year.
- The Superintendent addressed the 2.0 GPA requirements for students who want to participate in sports. He said an adjustment was made for the instance where a student with a 1.8 or 1.7 GPA will be placed on probation so that they will be allowed to play and the following year if they do not make a 2.0 GPA they may not be allowed to play. Probation can only occur once.
- Ms. Mateo reported that the Board at its last meeting collectively agreed to give Mr. Lee a 3 Year Contract extension.

PUBLIC COMMENTS

- Gloria Stewart expressed thanks to board members for extending Mr. Lee's contract. She also expressed concerns about the full time librarian at Oakwood Avenue School. She said the librarian should be shared with schools that have no librarian. She asked about Heywood's playground. She wants to know when the playground will be repaired.
- Mrs. Patrica Arthur expressed satisfaction at Mr. Lee's contract extension, stating that it should be put in writing. She asked for clarification about a resolution regarding cancelling the Bocchino Scholarship. Mr. James addressed her concerns.
- Lena Small expressed her satisfaction about Mr. Lee's Contract extension

- Tyrone Tarver congratulated Mr. Lee for the contract extension. He said that Orange continued to be a non-performing district, stating that SAT scores are low and students having low AYP. He wants to know what the Superintendent and the Board will do to address the situation. Mr. Lee said that his claim is inaccurate. He said more students are being exposed to STEM, high quality education. He said free SAT classes were offered to students and very few attend, that as a community leader, he should work with parents to encourage higher turnout in class and SAT preparatory classes. He said the last graduation rate was 93% and also student's achievements have been on an upward trend.
- Mr. Arthur Griffa said that he lived in Orange for over 30 years and noticed significant improvement in educational achievement. He also said that Orange has been blessed with an excellent superintendent in Mr. Lee.
