WHEREAS, the New Jersey Medical School Department of Pediatrics - Male Student Support Program (hereinafter "NJMS-MSSP") is a program that increases and enhances academic performance, awareness of preventative health behaviors and decrease "at risk" behavior for program participants; and,

WHEREAS, the NJMS-MSSP has utilized the premises of the Orange Board of Education to provide intervention for students; and,

WHEREAS, NJMS-MSSP provided services for the Fiscal Year 2018 and seeks to continue them through the Fiscal Year 2021 at a cost of \$93,157.00 and \$95,150.00 for Fiscal Year 2022; and,
