Stage 1: MSU's first step is to learn about the community and culture, as well as views about anxiety and mental health, through focus groups and individual interviews with students and parents/caregivers.

Stage 2: Year 2 will consist of evaluating a culturally sensitive intervention for anxiety with 15 students who are shy or nervous in school situations. The strategies are evidence-based interventions shown to be effective for improving anxiety. In addition, we will make sure to incorporate student feedback from Stage 1 regarding what will be most relevant for students in the Orange community. Two school counselors can be trained to deliver the intervention with our team.

Stage 3: Year 3 will more fully evaluate the benefits of the intervention compared to standard school services. Two additional school counselors will be trained to deliver the intervention with our team. This will involve 48 students who are shy or nervous in school situations: and
