



## What is it?

Title I, Part A (Title I) of the Elementary and Secondary Education Act, as amended by the Every Student Succeeds Act (ESEA) provides financial assistance to local educational agencies (LEAs) and schools with high numbers or high percentages of children from low-income families to help ensure that all children meet challenging state academic standards.

# OUR SCHOOL'S TITLE I PLAN

#### **SMART GOAL 1**

By June 2023, 70% of all self contained students will have met their NWEA goals and 70% of all students in Grades K – 7 will be on or above grade level as measured by the IREADY Math Intervention Screener.

NOV. 15: By EOC 1, 100% of all non self-contained students will be baselined with the IREADY Fall 2023 Math Diagnostic to determine current grade level scale score, placement and tier as well as 100% of all self contained SE students will be baselined with the NWEA Fall 2022 assessment.

FEB. 15: By EOC 2, 25% of all students in Grades K – 7 will meet their mid-year projected growth as measured by IREADY and NWEA (for self contained SE students only).

APR. 15: By EOC 3, 50% of all students in Grades K – 7 will meet their projected growth as measured by IREADY and NWEA (for self contained SE students only).

NOV 15: By EOC 1, a minimum of 100% of students will have taken their baseline SRI diagnostic to determine their Lexile level and goals set for individual growth by the end of the school year.

FEB 15: By EOC 2, 25% of students in grades 1 – 7 will meet their first cycle Lexile growth goals according to the SRI goals set in September 2023

<u>APR 15</u> : By EOC 3, 50% of students in grades 1 – 7 will meet their second cycle Lexile growth goals according to the SRI goals set in September 2023.

FEB 15: 80% of students have completed 6 lessons in the Second Step Curriculum.






