Community Eligibility Provision (CEP) 2020-2021 School Year Online Fillable Household Information Survey

Dear Parents, Guardians, and Caregivers,

We are pleased to inform you that the Orange Township Public Schools will continue to implement the option available to public schools participating in the National School Lunch and School Breakfast Programs called the Community Eligibility Provision (CEP) for the 2020-2021 School Year. **To ensure that your child(ren)'s school receives the applicable state benefits, you may complete your Household Information Survey online.**

Online Fillable Household Information Survey Instructions

As required, all enrolled students of the Orange Township Public Schools, **must fill out** a Department of Education Household Survey form **for all your children in your household** to be able to receive breakfast and lunch **at no charge**. The DOE Household Survey form must be submitted no later than **9/25/2020**. The DOE Household Survey will be on the District's website and on each school's website. Once you fill out the form, please email the completed form to lunchformsreturn@orange.k12.nj.us. You will receive a response that the lunch form has been received. For your convenience, there will be a hard copy of the DOE Household Survey and a drop box at each school location that we have the grab and go breakfast and lunch service should you choose to go that particular route. There is no need to do both; you can choose the option that works best for you. Available pick up and drop off of the form can be done between 7:30am and 1:30pm. See below for all locations.
